

# Sponsor Our Mission

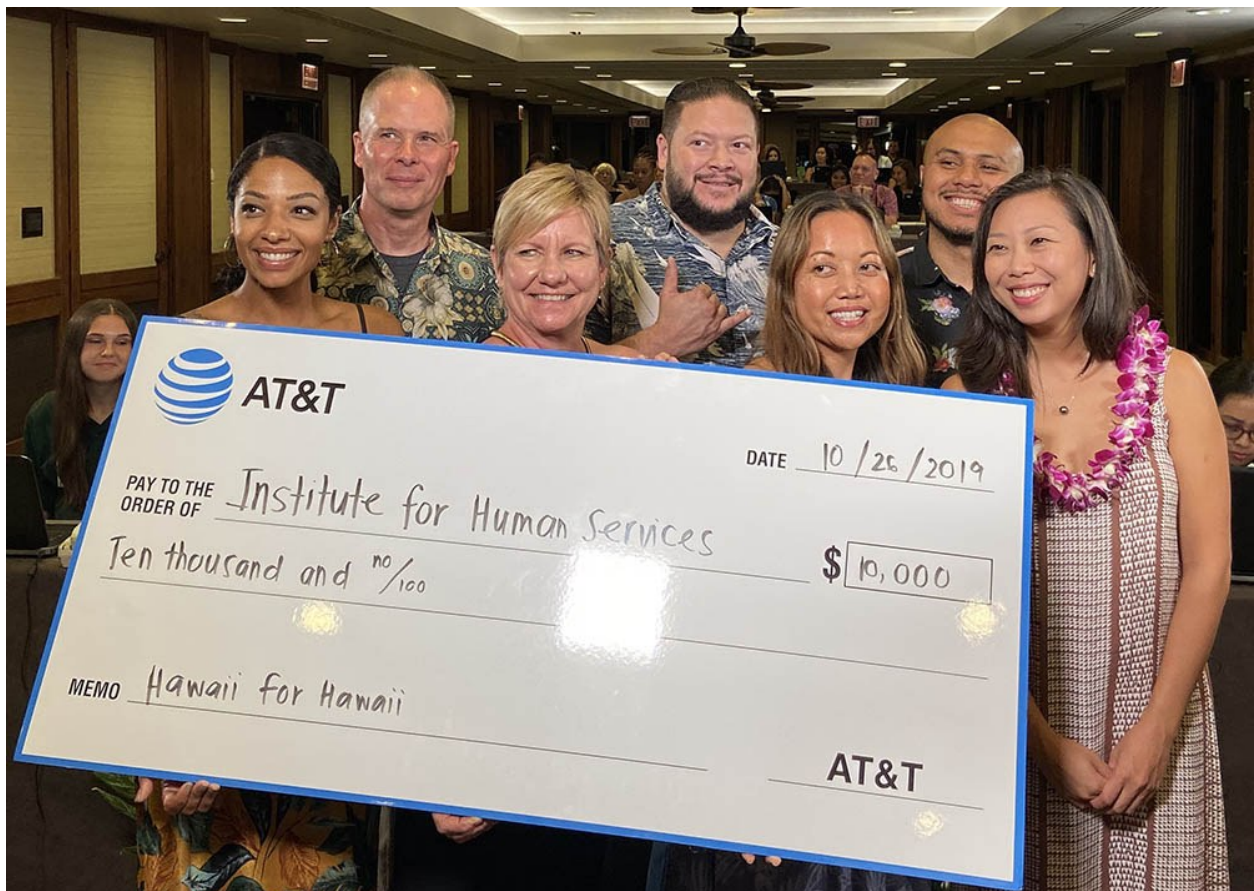
We simply could not do the work we do without the support of our amazing partners.
